Full Contest Terms and Conditions**

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY. BY ENTERING THE MINUTEMAN PRESS SURREY WIN A CAR WRAP CONTEST (THE "CONTEST"), THE ENTRANT AGREES TO BE BOUND BY ALL THE TERMS AND CONDITIONS CONTAINED HEREIN. The selected winners will be required to acknowledge via phone his/her receipt of the notification of eligibility for the prize. If no response is received by Minuteman within three (3) business days of initial notification, the prize will be forfeited and an alternate winner from the remaining eligible entries will be selected. Up to three redraws will be made.

To be declared a winner, the selected winner must:

- A. First correctly answer, unaided, a time-limited, mathematical skill-testing question;
- B. Sign a release form, in a form acceptable to Minuteman; and
